- Bullying Prevention; Student Instruction, IC 20-30-5-5.5
 - \circ By October 15 of each year
 - Public Schools
 - Age appropriate, research based instruction focusing on bullying prevention required for students in grades 1-12
 - Instruction may be delivered by a school safety specialist, school counselor, or any other person with training and expertise in the area of bullying prevention and intervention

 - School Corporation and Charter Schools, grade 8
 - Effective July 1, 2019
 - State developed career standards for all students in grade 8 that include the instruction in and use of either:
 - Indiana Career Explorer Program and Standards; or
 - an alternative intent based system and standards (approved by the state board) that provide students with career and college planning resources

- Child Abuse and Child Sexual Abuse Instruction, IC 20-30-5-5.7
 - By December 15, 2018, and each December 15 thereafter
 - Public Schools, including charter schools and accredited nonpublic schools

- Instruction may be delivered by a school safety specialist, school counselor, or any other person with training and expertise in the area of child abuse and child sexual abuse.

• Good Citizenship Instruction, IC 20-30-5-6

- Public schools
- Integrating instruction into the current curriculum that stresses the importance of the following:
 - Being honest and truthful
 - Respecting authority
 - Respecting the property of others
 - Always doing the student's personal best
 - Not stealing
 - Possessing the skills (including methods of conflict resolution) necessary to live peaceably in society and not resorting to violence to settle disputes
 - Taking personal responsibility for obligations to family and community
 - Taking personal responsibility for earning a livelihood
 - Treating others the way the student would want to be treated
 - Respecting the national flag, the Constitution of the United States, and the Constitution of the State of Indiana
 - Respecting the student's parents and home
 - Respecting the student's self
 - Respecting the rights of others to have their own views and religious beliefs

• Graduation Plan, <u>IC 20-30-4</u>

- School Corporation
- Initial Graduation Plan, Grade 6
 - Required for students in grade 6
 - Developed by a student and the student's parent
 - Must become a part of the student's permanent school record
 - Required components included in the law

- Graduation Plan, high school
 - In consultation with the student's school counselor, after seeking consultation with the student's parents, graduation plan shall be further developed before the student completes grade 9
 - Required components included in the law
 - Student's school counselor, in consultation with the student and student's parent, shall review the plan annually to determine if student is progressing toward fulfillment of plan;
 - if not progressing toward fulfillment, school counselor shall provide counseling to advise the student of credit recovery options and services available;
 - if not fulfilling due to not passing the graduation exam or failing to meet a postsecondary readiness competency (for the graduation pathways), the counselor shall meet with the teacher assigned to the student for remediation for that competency area, parents, and student to discuss remediation and to plan to meet requirements.
